# **Lear**ner Pathways Modernization Initiative (LPMI) Update

ACAT LPMI Phase 2: Transfer System Modernization is getting closer to rollout, with three system working groups (advisory; admissions and transfer; website modernization) providing important guidance for this work.

## May 2016:

• Institution Contact Persons are completing key data migration activities in preparation for transition to new transfer system technology and tools. Contact Persons are holding a meeting on May 17 in Calgary at the Mount Royal University. Beginning on May 27, institutions will not be able to add any new institution agreements or other data into Alberta's current TAARS database that is displayed in the Transfer Alberta Search Tool and Mobile App.

### June to November 2016:

- As the new transfer system is developed, student/stakeholder access to all current transfer agreements and high school equivalencies information will be maintained through the Transfer Alberta Search Tool and Mobile App. Addition of new information will be temporarily static, with no loss of access to existing data. Throughout the development and rollout, Institution Contact Persons will be provided with details about and stages for data migration, uploading, collection, system testing, and implementation.
- Initial availability of the Transfer Alberta website, and the updated Search Tool and Mobile App is estimated to be early July. Availability of the New Learner Pathways Catalog, and testing of the Transfer Credit Evaluation System (TCES) is estimated to be October/November.

ACAT is pleased to invite submissions for Proposals regarding research on the success of transfer credit students.

Proposal Deadline: June 20, 2016

Proposal Topics: How successful are post-secondary transfer students in Alberta? How well do postsecondary transfer students do in comparison to the direct entry students in Alberta?

Proposal Expectations: Selected contractor(s) will focus on data collection and analysis for approximately three (3) Alberta post-secondary institutions, providing research findings (data collection) and analysis (research paper/report).

Contract Amount: Between one (1) and three (3) research contracts are planned to be issued, each receiving up to \$16,650 to a maximum total of \$50,000 for all contracts issued.
